

Cookies Policy

The website queensdistrict.ro (hereinafter known as „**the Website**“) is managed by SPEEDWELL SRL (hereinafter known as „**the Controller**“). The Website uses cookies and similar technologies (together generically referred to as „cookies“). The information presented below aims at providing users with more details on the placing, use and management of the cookies used by the Website.

We use cookies in order to ensure the proper functioning of the Website and to optimize its content, as well as in order to analyze traffic and offer the visitors a better experience when browsing the website. We do not conduct personalized advertising or marketing activities based on cookies or cookie generated data.

Cookies offer website owners important feedback on the way visitors browse the websites, so that such websites may be more efficient and more accessible.

In this Cookies Policy you will find information about what a cookie represent, what are the purposes for using cookies and what are the implications for visitors, as a result of accepting the cookies used by this site.

What is a cookie?

An “internet cookie” (also known as “browser cookie”, “HTTP cookie” or simply “cookie”) is a file of small dimensions, consisting of letters and numbers which will be stored on the user’s computer, mobile device or other equipment from which internet is accessed.

When you access the site as a visitor, a cookie is sent to your internet browser and saved to your computer’s hard disk, but you can block the saving of cookies by changing your browser settings.

A cookie consists of two parts: name and content (or value). Technically, only the webserver which sent the cookie may access it again when the user returns to the website associated with such webserver.

The cookies by themselves do not require personal data in order to be used and, in most cases, do not identify internet users, as the information collected through cookies are not of such nature as to lead to the identification of internet users. By means of cookies, the following types of information may however be collected: IP address, geo-location data, data regarding the operating system, data regarding the resolution of the devices being used, information regarding website visits (including the number of visits, the time spent on the website, the manner of accessing the website, user behavior on the website), data regarding organic traffic.

Although cookies are stored in the memory of your computer, phone, tablet or any other device used to access a site, cookies cannot access or read other information stored in that device.

What is the lifetime of a cookie?

Depending on their lifetime, cookies may be classified in session cookies or persistent cookies. Session cookies have a storage duration that is limited to the length of a user session. When closing the session or the browser, the stored information is deleted.

Persistent cookies are stored in a user's device for a variable amount of time, longer than the duration of a session, and are not deleted when closing the session or the browser, but at the expiry of said duration.

What are third party cookies?

Content sections from certain websites or certain website functionalities may be provided through third parties / providers (for example, a video). Such third parties may place these cookies on the website (called "third party cookies" since they are not placed by the owner of the website). The third party providers also have to observe the legal regulations in force and the confidentiality policies of the website owner. More details regarding the manner in which these third parties handle the placement and use of cookies and similar technologies may be found in the corresponding policies of such third parties.

We have included below, in the "What cookies does this website use?" section the third parties cookies identified on the Website.

What cookies does this Website use?

Our Website uses the following types of cookies:

Strictly necessary cookies

Strictly necessary cookies are essential for the proper functioning of the Website. These allow the use of basic functions like page navigation and access to secure areas of the Website. The Website cannot function properly without these cookies.

Adapt browser settings to cookies

If you are the only person using the computer, you may set long terms of expiry for browsing history. If you share the computer, you may consider setting the browser to delete the browsing data each time you close the browser.

How can I stop the cookies?

For cookies which are not strictly necessary you may withdraw your consent at any time by accessing the “Update your consent” section available in the footer of our Website.

In addition, users can configure their browser to reject all the cookie files or to alert the user when cookies are sent to the device.

It is important to note that the deactivation or refusal to receive certain types of cookies can make certain sections of the website difficult to view and use.

All the modern browsers offer the possibility to change the settings of cookies.

You can configure the settings of the cookies following the instructions below:

a. On computer
